




## OBSERVATION

**Moumita Poddar:-** The petitioner, Moumita Poddar obtained only 39% in aggregate in her B.A. examination and she had no B. Ed. Degree on the date of her alleged appointment. The petitioner having no requisite qualification, is claiming herself to be an Asstt. Teacher, History (Pass) in the Bhandari GachSuru Bari High Madrasah at Jalpaiguri. As per the report of the Headmaster of Bhandari Gach Suru Bari High Madrasah, Md. Noushad Ali, the Rules of Recruitment of teaching and non-teaching staff were not followed in the alleged recruitment of the petitioner, Moumita Poddar. Moreover, she had no requisite qualification to be appointed as Asstt. Teacher. The Headmaster of the said Madrasah further stated that the Resolution Book reveals that the same was commenced on 11/11/2015 and stated thereafter, no resolution has been recorded/passed since 13/01/2016 in his Madrasah and that so why, he could not produce any other Resolution Book. The Headmaster also did not produce the original Attendance Register. It is evident from the report submitted by the D.I. of Schools, Jalpaiguri that the alleged appointment of the petitioner, Moumita Poddar, was not done following the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09/02/2015. It is apparent that the Headmaster had produced one Resolution Book in all probabilities, the said Resolution Book had been manufactured. It is next to impossible that the concerned Madrasah did not pass any resolution in the year 2016. Admittedly, there is no signature of the petitioner Moumita Poddar in the Resolution Book.

Under such circumstances, we are of the considered opinion that the petitioner Moumita Poddar was never recruited following the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09/02/2015 and she never worked in the Madrasah. The Work Done Certificate as well as the Resolution Book have been manufactured for the purpose of verification by suppressing the official Attendance Register and the original Resolution Book of the Managing Committee.




Debjani Dutta:- The petitioner is claiming herself as Gr. 'D' employee of Bhandari Gach Suru Bari High Madrasah, Jalpaiguri. As per the statement of Md. Noushad Ali, the Headmaster of the Bhandari Gach Suru Bari High Madrasah, the Rules of Recruitment in the alleged recruitment of Debjani Dutta being No. 93-SE/S/10R-14/2013 dated 09/02/2015 were not complied with. The report of the D.I. of Schools, Jalpaiguri also corroborated that the Rules of Recruitment were not complied with in the recruitment of the petitioner, Debjani Dutta. Abu Hossain:-The petitioner, Abu Hossain obtained only 38.53% in aggregate in his B.A. examination and he had no B. Ed. Degree on the date of his alleged appointment. The petitioner having no requisite qualification, is claiming himself to be an Asstt. Teacher, Bengali (Pass) in the Bhandari Gach Suru Bari High Madrasah at Jalpaiguri. As per the report of the Headmaster of Bhandari Gach Suru Bari High Madrasah, Md. Noushad Ali, the Rules of Recruitment of teaching and non-teaching staff were not followed in the alleged recruitment of the petitioner, Abu Hossain. Moreover, he had no requisite qualification to be appointed as Asstt. Teacher. 

The petitioner having no requisite qualification, is claiming himself to be an Asstt. Teacher, Geography in the Bhandari Gach Suru Bari High Madrasah at Jalpaiguri. As per the report of the Headmaster of Bhandari Gach Suru Bari High Madrasah, Md. Noushad Ali, the Rules of Recruitment of teaching and non-teaching staff were not followed in the alleged recruitment of the petitioner, Md. Wahedul Islam. Moreover, he had no requisite qualification to be appointed as Asstt. Teacher.
