
Sk. Aslam Ali, Group-C (Librarian): On the strength of the Resolution of the Managing Committee vide Special Meeting No. SPL-01A/BHAAHMHS/ 2016 dated 09.11.2015, the petitioner is claiming himself as Librarian of Bijoyramchawk Haji Ahammad Ali High Madrasah (H.S). The petitioner has filed one Work Done Certificate issued by Sk. Nazrul Islam. As per Petitioner, he appeared in an interview and he never appeared in any written examination for being recruited as Librarian. The copies of Attendance Register filed by the petitioner have not been certified by the competent authority of the Madrasah or the Teacher-in-Charge. The said photo copies of Attendance Register are not the valid documents of the Madrasah.


The Teacher-in-Charge, Md. Ariful Anwar by producing the original Attendance Register and the Resolution Book of the Managing Committee, has specifically stated that no Resolution was ever adopted by the Managing Committee as mentioned in the alleged appointment letter of the petitioner and the petitioner never signed in the official Attendance Register. The Secretary of the Madrasah had no occasion to issue Work Done Certificate in favour of the Petitioner. The Teacher-in-Charge did not issue any Work Done Certificate.


The A.D.I., Contai, Subhashis Mitra has specifically stated by filing a report thereof, the claim of the petitioner is fake and fabricated simply on the ground that there was no intimation to A.D.I., Contai about such appointment and there was no sanction post of Librarian in the Madrasah.

It is, therefore, apparent that there was no sanction post of Librarian. The petitioner has claimed on the basis of imaginary Resolution of the Managing Committee. There is no signature of the petitioner in the official Attendance Register.

Under the circumstances stated above, we are of definite opinion that the petitioner was never recruited following the Rules of Recruitment being Govt. Notification No. 93-SE/S/10R-14/2013 dated 09.02.2015 and he never worked in the Madrasah.






