


OBSERVATION


Sk. Mokhlesur Rahaman, Asstt. Teacher, Arabic (Pass) : The claim of the Petitioner is that he has been appointed as Assistant Teacher, Arabic (Pass) on 07.10.2015 at Chhutargeria F.B. High Madrasah, Paschim Medinipur by the Managing Committee and he has been working since then. The documents produced by the Petitioner reveals that the petitioner obtained only 39.07% marks in aggregate in Graduation and he had no B.Ed. degree at the time of his appointment. From the documents produced by the Petitioner, it is crystal clear that the petitioner had no requisite qualification to be appointed as Assistant Teacher.


Secondly, the Resolution of the Managing Committee being no. 139 dated 07.10.2015 clearly show that the recruitment rules were not complied with at the time of giving appointment to the Petitioner. The Headmaster, Md. Israfil Khan and D.I. of Schools, Paschim Medinipur by filing a report have specifically stated that the rules of recruitment being no. 93-SE/S/10R-14/2013 dated 09.02.2015 were not complied with at the time of alleged appointment of Sk. Mokhlesur Rahaman. The Headmaster, however, admitted that Sk. Moklesur Rahaman has been working since 07.10.2015. The official Attendance Register maintained by the Madrasah, however, does not reflect the attendance/signature of the Petitioner. The separate Attendance Register also cannot be taken into consideration regarding valid appointment and working in the Madrasah.

The D.I. of Schools, Paschim Medinipur has specifically stated that pursuant to the direction of the order of Hon'ble Supreme Court, all the appointments including the Petitioner was scrutinized and found illegal and that's why no appointment was given to the Petitioner.

In short, we are of the considered opinion that Sk. Mokhlesur Rahaman was never recruited following the rules of recruitment being no. 93-SE/S/10R-14/2013 dated 09.02.2015 and he had no qualification to be appointed as Assistant Teacher, Arabic (Pass).


OBSERVATION


Sahana Khatun, Assistant Teacher, Bengali (Pass) : She is claiming herself as Assistant Teacher of Chhutargeria F.B. High Madrasah, Paschim Medinipur. Admittedly, Sahana Khatun has no B.Ed. degree on the date of her alleged appointment in this Madrasah and therefore, she had no requisite qualification to be appointed as Assistant Teacher in terms of alleged eligibility as decided in N.C.T.E. guidelines. The resolution being no. 139 dated 07.10.2015 of the Managing Committee also reveals that the rules of recruitment prevailing at that point of time being no. 93-SE/S/10R-14/2013 dated 09.02.2015 were not complied with at the time of giving appointment to the Petitioner. The official Attendance Register also does not bear the signature of the Petitioner. To accept that, she has been working since 08.10.2015. Separate Attendance Register having no signature of any authorized office bearer of the Madrasah would not prove the case of the Petitioner that she has been working in the Madrasah since 08.10.2015.

The D.I. of Schools, Paschim Medinipur has specifically stated that pursuant to the direction of the order of Hon'ble Supreme Court, all the appointments including the Petitioner was scrutinized and found illegal and that's why no appointment was given to the Petitioner.

In conclusion, we are of the considered opinion that Sahana Khatun was never recruited following the rules of recruitment being no. 93-SE/S/10R-14/2013 dated 09.02.2015 and she had no requisite qualification to be appointed as Assistant Teacher, Bengali (Pass).




OBSERVATION


Jaynal Abedin Mollick, Assistant Teacher, Bio-Science (Pass) : The claim of the petitioner is that he has been appointed as Assistant Teacher, Bio-Science (Pass) on 07.10.2015 by the Managing Committee of Chhutargeria F.B. High Madrasah, Paschim Medinipur. Petitioner, Jaynal Abedin Mollick obtained 45.7% in B.Sc. and had no B.Ed. degree on the date of the alleged appointment at the Madrasah. The resolution dated 07.10.2015 being meeting no. 139 clearly reveals that the rules of recruitment being no. 93-SE/S/10R-14/2013 dated 09.02.2015 were not complied with at the time of giving alleged appointment to the Petitioner. No Work Done Certificate was issued by the Headmaster of the Madrasah considering the entire materials and documents produced by the petitioner.

The D.I. of Schools, Paschim Medinipur has specifically stated that pursuant to the direction of the order of Hon'ble Supreme Court, all the appointments including the Petitioners were scrutinized and found illegal and that's why no approval was given to the Petitioner.

We are of the considered opinion that the petitioner was never recruited following the rules of recruitment being no. 93-SE/S/10R-14/2013 dated 09.02.2015 and he had no requisite qualification to be appointed as Assistant Teacher, Bio-Science (Pass).
