




## OBSERVATION

He was never appointed following Recruitment Rules and Nasirul Hossain never worked in Ghola N.H.M High Madrasah (H.S). The copy of Resolution filed by Nasirul Hossain revealed that one Kaji Zamiruddin was President but it is the fact that one Kaji Zamiruddin as President but in fact one Hyder Molla was the President of the Madrasah on 04.04.2016. The D.I of Schools corroborated the said contention of the Teacher-in-Charge. In short, it may safely be stated that Nasirul Hossain was never recruited following the Rules of Recruitment and he never worked at Ghola N.H.M High Madrasah (H.S). The claim of Nasirul Hosain is false and fabricated. The Teacher-in-Charge of Ghola N.H.M High Madrasah (H.S) has filed all attested copies of the Resolution, original Attendance Registers of the Madrasah and we do not find any whisper regarding the presence of Nasirul Hossain in such papers.


## OBSERVATION

The Teacher-in-Charge, Md.
