Jahurul Hoque Mondal: - The photostat copy of the appointment letter reveals that Jahurul Hoque Mondal was appointed as Asstt. Teacher at Kalmati High Madrasah, Coochbehar on 18/09/2018 and he reported his duty before the Headmaster of Kalmati High Madrasah on 19/09/2018.

Bilal Hossain Mallik, the Headmaster of Kalmati High Madrasah, admitted that there are two attendance registers for approved teachers and another for non-approved teachers. Curiously enough, the appointment letters were issued by Bilal Hossain Mallik, the Headmaster of Kalmati High Madrasah, Coochbehar ignoring the Secretary of the Managing Committee and all other members of the Managing Committee. He also admitted that a separate Resolution Book has been prepared for purpose of giving appointment in the year 2015 and 2018. The original Resolution Book of 2015 maintained by the Managing Committee, did not reveal anything about alleged appointment of Jahurul Hoque Mondal. The Headmaster, Bilal Hossain Mallik played a pivotal role in manufacturing the document and falsely projecting the said Jahurul Hoque Mondal as legally recruited employee. No appointment letter of 2018 has been produced by the petitioner.

In terms of the report of Samar Chandra Mondal, the D.I. of Schools, Coochbehar, the applicants including Jahurul Hoque Mondal were never recruited following G.O. No. 93-SE/S/10R-14/2013 dated 09/02/2015 and 486-MD/O/2M-11/2016 dated 03/03/2016. The D.I. of Schools, Coochbehar further stated that the Madrasah authority cannot appoint any teaching or non-teaching staff without previous sanction of the state as contemplated in Section 4 (1) (ii) of The West Bengal Schools (Control of Expenditure) Act, 2005. Admittedly, no such sanction was taken by the Madrasah for appointment of Jahurul Hoque Mondal. Unfortunately, despite rejection of the claim by the D.I. of School, the petitioner, Jahurul Hoque Mondal has again filed his application for verification.

The petitioner is claiming that he was recruited on 18.09.2018 and he has been working in the Madrasah as Librarian since 19.09.2018. Being aware of the vacancy from one advertisement published in "UTTAR BANGA SANGBAD", the petitioner appeared in written examination and thereafter he was recruited as Librarian by the Madrasah. The petitioner has filed one Work Done Certificate issued by Headmaster, Bilal Hossain Mallick.

Bilal Hossain Mallik on the other hand has categorically stated that he had not fully complied with the recruitment rules in matters of appointment of the petitioner. Admittedly, there are two sets of Resolution Books of the Managing Committee. The original Resolution Books of the Managing Committee for the year 2015, 2016 and 2017 do not reflect any recruitment of Teachers or non-Teaching staff in the Madrasah.

A separate Resolution Book has been prepared by the Headmaster, Bilal Hossain Mallick. He has also recruited his nephew as Night Guard without having any sanctioned post in the Madrasah.

The separate Resolution Book appears to have been manufactured by the Headmaster. As per recruitment rule, the vacancy has to be published in two state level dailies, out of which one must be a Bengali newspaper. Admittedly, the vacancy was not published in any English newspaper having wide circulation through the state. No document has been produced to show that the recruitment rules were fully complied with in matters of alleged appointment of the petitioner

The Headmaster himself has admitted that the rules of recruitment as per Govt. Notification were not complied with.

Samar Chandra Mondal, D.I. of Schools has also stated by filing a specific report in respect of the petitioner that the petitioner was never recruited following the rules of recruitment and the claim of the petitioner as non-Teaching staff of the Madrasah is absolutely fake and fabricated.

On comparison of the Resolution Books for the year 2015, we find that the separate Resolution Book prepared by the Headmaster has bestowed all the powers of recruitment, issuance of appointment letter and reporting authority upon the Headmaster, whereas as per rules, the Secretary is authorized to issue appointment letter and the Secretary except the case of Headmaster is also the reporting authority. The Headmaster intentionally did not produce the Resolution Book of the Managing Committee of 2018 in order to suppress the actual state of affairs. However, having regard to the report of the D.I. of Schools, materials on record, the statement of the Headmaster and the petitioner, we are of considered opinion that the separate Resolution Book for the year 2015 has been prepared/manufactured by the Headmaster and the Headmaster intentionally suppressed the original Resolution Book of the Managing Committee for the year 2018. In absence of the original Resolution Book for the year 2018, we cannot say that the petitioner was recruited following the rules of recruitment.

Under the circumstances stated above, we have no hesitation to say that the petitioner was never recruited following the rules of recruitment as per Govt. Notification no. 486-MD/O/2M-11/2016 dated 03.03.2016.

In view of the circumstances stated hereinabove, we reject the Work Done Certificate issued by the Headmaster, Bilal Hossain Mallick, who appears to be the kingpin of illegal recruitment in the Madrasah ignoring the rules of recruitment.


