It is, therefore, apparent that in a desperate attempt to legalize the appointment of the petitioner to be appointed as Asst. Teacher, the Teacher-in-Charge was terrorized to issue Work Done Certificate and to sign on a written submission under the pressure of one Parvez Ahmed Mallick.


The D.I. of Schools also filed a report stating inter-alia that the petitioner was never recruited following Rules of Recruitment as per Govt. Notification No. 93-SE/S/10R-14/2013 dated 09.02.2015.







In support of his contention, he has filed Work Done Certificate issued by the present Teacher-in-Charge, Marui Beria Ainul Ulum Sr. Madrasah, South 24 Parganas. On scrutiny, we find that the petitioner has no requisite qualification (having no B.Ed. degree and less than 50% in aggregate) to be appointed as Assistant Teacher, Bengali. Sudip Kumar Maity, D.I. of Schools has specifically stated that no intimation/permission of the D.I. of Schools was ever taken by the Managing Committee of the Madrasah for the recruitment of the petitioner. On the contrary, the D.I. of Schools produced the declaration made by previous Teacher-in-Charge, Md. Nuruddin Mondal, the Teacher-in-Charge has denied all the contents of written submission filed under his signature on the ground that he was terrorized by one Parvez Ahmed Mallick son of the member of Zilla Parishad to put her signature on the last page of the written submission. Nuruddin Mondal has had no knowledge about the contents of the written submission or about the documents annexed therewith. He had no occasion to see the original Resolution Book for the period from 2015 to 2019. The D.I. of Schools also stated that the petitioner was never recruited following Rules of Recruitment and to that effect the previous Teacher-in-Charge had given a written declaration. Having regard to the statement of Teacher-in-Charge, D.I. of Schools and in absence of the original Resolution Book, we are of the considered opinion that the petitioner was never recruited following the Rules of Recruitment as per Govt. Orders No. 486-MD/O/2M-11/2016 dated 03.03.2016 and the petitioner (having no signature in the official Attendance Register) never worked in the Madrasah. The petitioner in a desperate move forcibly took the signature of the Teacher-in-Charge on the Work Done Certificate and on the alleged declaration of the Teacher-in-Charge. Under the circumstances stated hereinabove, we are of the considered opinion that the petitioner was never recruited following Rules of Recruitment as per Govt. Notification No. 486-MD/O/2M-11/2016 dated 03.03.2016 and the petitioner never worked in that Madrasah.






OBSERVATION
