




OBSERVATION

Sk. Umar Faruque, Asstt. Teacher Arabic (H/PG) : The Petitioner did not turn up despite service of notices atleast on 3 occasions. No original document has been produced to verify the educational qualification or any of the documents filed by the petitioner along with the representation. Record reveals that Sk. Umar Faruque had had no requisite qualification to be appointed as Assistant Teacher. The Teacher-in-Charge of Mohammadpur Darul Ulum Sr. Madrasah and the District Inspector of Schools, Purba Medinipur have unequivocally stated that the alleged appointment of said Sk. Umar Faruque should be treated as fake and illegal because there is no documentary evidence to establish that he was recruited following Rules of Recruitment. No document is found about his working in the said Madrasah. He was never recruited following Rules of Recruitment and never worked in the Madrasah. We do not find the signature of the petitioner in the official attendance register of the Madrasah


