




OBSERVATION

Arsed Mollah, Group-D : Admittedly, the Petitioner never appeared in written examination or appeared before any Interview Board for being recruited as Group-D of Nimdighi High Madrasah. The Headmaster, Sk. Sarin Sahaj has specifically stated that the Resolution Books of the Managing Committee for the year 2015-2016 were not handed over to him by Teacher-in-Charge. No attested copy of the Resolution Book for the year 2016 by which the petitioner was appointed, has been filed by the Petitioner to show that the Petitioner was recruited following the Rules of Recruitment. The Official Attendance Register does not bear the signature of the petitioner. The photostat copy of the Attendance Register submitted by the petitioner was not attested by the Headmaster or any appropriate office bearer to justify that the Petitioner has been working as Group-D employee of that Madrasah. The D.I. of Schools, Howrah has stated by filing a report that the he had no knowledge about alleged recruitment of the Petitioner following the Rules of Recruitment.

Under the above circumstances, we are of the considered view that the Petitioner was never recruited following the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02.2015 and he never worked in the Madrasah under reference, as claimed by him.


OBSERVATION


Md. Ibrahim Mallick, Assistant Teacher, Arabic (Pass) : The Petitioner is claiming himself as permanent Teacher of Nimdighi High Madrasah. said to have been recruited on 05.02.2016 and has been working since then.


The Petitioner obtained 43.3% in aggregate in M.M. examination and he had no D.L. Ed. degree on the date of his recruitment.

Admittedly, the Petitioner had no requisite qualification to be appointed as Assistant Teacher. There is no resolution of the Managing Committee showing the mode and manner of recruitment of the petitioner. The Headmaster, Sk. Sarin Sahag has also stated that he never seen the petitioner to work as Assistant Teacher. No attested copy of Resolution Book filed by the Petitioner also reveals that the Rules of Recruitment No. 93-SE/S/10R-14/2013 dated 09.02.2015 were never complied with in the alleged recruitment of the Petitioner. The official Attendance Register produced by the Headmaster also does not bear the signature of the Petitioner. The D.I. of Schools, Howrah by filing a report has stated that there was no intimation to the Government about alleged recruitment of the Petitioner following the Rules of Recruitment.




Serina Yasmin, Assistant Teacher, Arabic (Pass) : The Petitioner is claiming herself as permanent Teacher of Nimdighi High Madrasah, said to have been recruited on 05.02.2016 and has been working since then.


The Petitioner obtained 41.38% in aggregate in B.A. examination and she had no B.Ed.degree on the date of her recruitment.

Admittedly, the Petitioner had no requisite qualification to be appointed as Assistant Teacher. There is no resolution of the Managing Committee showing the mode and manner of recruitment of the petitioner. The Headmaster, Sk. Sarin Sahaj has also stated that he has never seen the petitioner to work as Assistant Teacher. No attested copy of Resolution Book filed by the Petitioner also reveals that the Rules of Recruitment No. 93-SE/S/10R-14/2013 dated 09.02.2015 were never complied with in the alleged recruitment of the Petitioner.
