


OBSERVATION


Lilufa Yasmin, The petitioner is claiming that she has been working in Takipur High Madrasah as Asstt. Teacher Bengali (pass) since 14.09.2017. The photocopy of appointment letter revealed that Lilufa Yasmin was appointed purely on temporary basis. Lilufa Yasmin does not have requisite qualification to be appointed as Assistant Teacher. We do not find any resolution to the affect that Lilufa Yasmin was recruited following the rules of recruitment being memo no. 486-MD/O/2M-11/2016 dated 03.03.2016. The Headmaster, Takipur High Madrasah, Azizur Islam and the D.I. of Schools both have unequivocally stated that Lilufa Yasmin was never recruited following the rules of recruitment. We do not find her signature in the official attendance register maintained by the Madrasah. No resolution about appointment of Lilufa Yasin is available in the original Resolution Book. We are of considered opinion that Lilufa Yasmin was never recruited following rules of recruitment. She does not have requisite qualification for being recruited as Assistant Teacher. She is not entitled to get any salary. The Headmaster of Takipur High Madrasah has also filed number of documents in order to establish that the claim of Lilufa Yasmin and others is false, fabricated and they are not entitled to get any relief as prayed for. The Headmaster or any Teacher In-charge never issued any Work Done Certificate in favour of Lilufa Yasmin.







OBSERVATION

Channihar Khatun: Despite successive service of notices, Channihar Khatun did not turn up. The so called appointment letter filed by Channihar Khatun revealed that she was appointed on 27.10.2019 on temporary basis. The Headmaster, Azizul Islam and D.I. of Schools, Murshidabad have unequivocally stated that Channihar Khatun was never recruited following rules of recruitment in absence of any original document. We could not even verify her educational testimonials or any other documents. The Headmaster has also filed number of documents in order to show that the claim of Channihar Khatun is false and fabricated. The original attendance register maintained by the Madrasah does not bear the signature of Channihar Khatun. In such circumstances we are of the considered opinion that Channihar Khatun was never recruited following the rules of recruitment being memo no. 486-MD/O/2M-11/2016 dated 03.03.2016 as Group-D employee in Takipur High Madrasah and therefore she is not entitled to get any salary.







OBSERVATION

Ayesha Siddika : The photocopy of appointment letter of the Petitioner revealed that she was appointed on 06.09.2017 on temporary basis. The Headmaster, Azizul Islam and D.I. of Schools of Murshidabad have specifically stated that Ayesha Siddika was never recruited following the rules of recruitment in Takipur High Madrasah and her claim is false and fabricated. On scrutiny of the original Resolution Book of the Managing Committee, we do not find any such resolution by which Ayesha Siddika was recruited as Assistant Teacher in Language Group Bengali. We also do not find any signature in the official attendance register maintained by the Madrasah. The Headmaster, Azizul Islam has filed number of documents in order to justify that the claim of Ayesha Siddika is false and fabricated. In fine, we are of the considered opinion that Ayesha Siddika was never recruited following the rules of recruitment and she is not entitled to get any salary. She never worked in Takipur High Madrasah and her claim is based on false and fabricated documents.



OBSERVATION


Md. Mohibul Sk. : The photocopy of appointment letter of the Petitioner revealed that he was appointed on 06.09.2017 on temporary basis. The Headmaster, Azizul Islam and D.I. of Schools of Murshidabad have specifically stated that Md. Mohibul Sk. was never recruited following the rules of recruitment in Takipur High Madrasah and his claim is false and fabricated. On scrutiny of the original Resolution Book of the Managing Committee, we do not find any such resolution by which Md. Mohibul Sk was recruited as Assistant Teacher Arabic (Pass). We also do not find any signature in the official attendance register maintained by the Madrasah. The Headmaster, Azizul Islam has filed number of documents in order to justify that the claim of Md. Mohibul Sk is false and fabricated. In fine, we are of the considered opinion that Md. Mohibul Sk. was never recruited following the rules of recruitment and he is not entitled to get any salary. He never worked in Takipur High Madrasah and his claim is based on false and fabricated documents.





The Headmaster, Azizul Islam and D.I. of Schools of Murshidabad have specifically stated that Md. Mohibul Sk was never recruited following the rules of recruitment in Takipur High Madrasah and his claim is false and fabricated. On scrutiny of the original Resolution Book of the Managing Committee, we do not find any such resolution by which Md. Hasibur Rahaman was recruited as Assistant Teacher Math (Pass). We also do not find any signature in the official attendance register maintained by the Madrasah. The Headmaster, Azizul Islam has filed number of documents in order to justify that the claim of Md. Hasibur Rahaman is false and fabricated. In fine, we are of the considered opinion that Md. Hasibur Rahaman was never recruited following the rules of recruitment and he is not entitled to get any salary. He never worked in Takipur High Madrasah and his claim is based on false and fabricated documents.







Samiul Kabir: The photocopy of appointment letter of the Petitioner revealed he was appointed on 29.10.2019 on temporary basis. The Headmaster, Azizul Islam and D.I. of Schools of Murshidabad have specifically stated that Samiul Kabir was never recruited following the rules of recruitment in Takipur High Madrasah and his claim is false and fabricated. On scrutiny of the original Resolution Book of the Managing Committee, we do not find any such resolution by which Samiul Kabir was recruited as Assistant Teacher Geography (Pass). We also do not find any signature in the official attendance register maintained by the Madrasah. The Headmaster, Azizul Islam has filed number of documents in order to justify that the claim of Samiul Kabir is false and fabricated. In fine, we are of the considered opinion that Samiul Kabir was never recruited following the rules of recruitment and he was not entitled to get any salary. He never worked in Takipur High Madrasah and his claim is based on false and fabricated documents. In such circumstances we are of the considered opinion that Samiul Kabir was never recruited following the rules of recruitment being memo no. 486-MD/O/2M-11/2016 dated 03.03.2016 as Asstt. Teacher Geography (Pass) in Takipur High Madrasah and therefore he is not entitled to get any salary. The Petitioner is claiming that he was appointed on 27.10.2019 as Asstt. Teacher (Geography). Admittedly the Petitioner completed his graduation in Geography from the University of Kalyani in the year 2020. Therefore question of appointment as Asstt. Teacher (Geography) prior to completion of graduation does not arise.







The Headmaster, Azizul Islam and D.I. of Schools of Murshidabad have specifically stated that Samiul Kabir was never recruited following the rules of recruitment in Takipur High Madrasah and her claim is false and fabricated. On scrutiny of the original Resolution Book of the Managing Committee, we do not find any such resolution by which Rekha Khatun was recruited as Assistant Teacher English (Pass). We also do not find any signature in the official attendance register maintained by the Madrasah. The Headmaster, Azizul Islam has filed number of documents in order to justify that the claim of Relkha Khatun is false and fabricated. In fine, we are of the considered opinion that Rekha Khatun was never worked in Takipur High Madrasah and her claim is based on false and fabricated documents. In such circumstances we are of considered opinion that Rekha Khatun was never recruited following the rules of recruitment being memo no. 486-MD/O/2M-11/2016 dated 03.03.2016 as Asstt. Teacher English (Pass) in Takipur High Madrasah and therefore she is not entitled to get any salary.


